BEACH COTTAGE POLICY INFORMATION

(RULES & RATES ARE SUBJECT TO CHANGE)

BEACH COTTAGE RENTAL PROGRAM

includes 24 cottages located at White Plains and Nimitz Beach at Barbers Point in Hawaii, on the island of Oahu.

WHITE PLAINS DUPLEX (6)

(6) Two-bedroom/one bath w/ washer & dryer

WHITE PLAINS CEDAR (1)

(1) Two-bedroom/two bath w/ washer & dryer

WHITE PLAINS HOMES (2)

(2) Three-bedroom/two bath w/ washer & dryer

NIMITZ BEACH DUPLEX (10)

(8) Two-bedroom/one bath w/ washer & dryer

(2) One-bedroom/one bath w/ washer & dryer
(Handicap accessible)

NIMITZ COVE DUPLEX (4)

(4) Two-bedroom/one bath w/ washer & dryer

NIMITZ COVE CEDAR (1)

(1) Two-bedroom/two bath w/ washer & dryer

MAXIMUM OCCUPANCY:

(2) Bedroom cottages sleeps max (6) people

(3) Bedroom cottages sleeps max (8) people

RESERVATIONS ELIGIBILITY

The reservation requirements and categories for eligible patrons are as follows:

CATEGORY 1

Includes Active Duty and their family members with a valid CAC/Military ID. Reservations may be made up to one (1) year in advance.

CATEGORY 2

Includes Retirees, DoD Civilians and Patron Expansions. All must have a valid CAC/Military ID. Reservations can be made up to six (6) months in advance.

AUTHORIZED PATRONS

The cottages are available for daily rental by the following authorized patrons:

- a. Active duty military to include foreign services and Coast Guard.
- b. Retired military
- c. Members of Reserve components
- d. Other military separated from the Armed Forces and their family members to include EX-POW, Medal of Honor recipients, and honorably discharged veterans with 100% service-connected disability, involuntarily separated service members under the Transition Assistance Management Program, voluntary separation under the Voluntary Separation Incentive (VSI) and Special Separation Benefit (SSB) Programs for two years after separation.
- e. Family members to include spouse and children (age 21 & older) of those eligible patrons in categories (a) through (d).
- f. Department of Defense (DoD) Civilians and MWR/NEX/AAFES NAF employees, active or retired.
- g. Veterans
- h. One cottage per valid CAC/Military ID holder.

BEACH COTTAGE POLICY INFORMATION

A military ID holder is limited to one (1) reservation per ID. No more than one (1) reservation under one (1) name per military ID is allowed. Any reservations over the limit per military ID will be cancelled without notice. Civilian guests must be escorted onto the installation and accompanied at all times by the military ID cardholder. Any reservations made in violation of these policies will be cancelled without notice. Failure to abide by these regulations will be cause for eviction.

PAYMENT INFO

Payment in full is due upon check-in at the ITT Office. A valid major credit card must be presented at check-in. No Checks or Cash will be accepted.

DEPOSITS

A one night deposit will be auto charged 14 days prior to arrival. If credit card is declined; sponsor will be notified to provide a valid credit card within 24 hours or reservations will be auto canceled.

CANCELLATIONS

Cancellations must be received a minimum of 14 days prior to check-in date. Cancellations or revisions/modifications received within 14 days of reservation will result in forfeiture of a rental fee of (1) night.

NO SHOWS

A charge will be assessed of a rental fee of (1) night.

CHECK IN/OUT

Check-in is 1500 – 1800 daily. Checkout is no later than 1100 at the BPT Beach Cottage Reservations & ITT Office. A charge of \$25 per half hour will be assessed for late checkout.

DISCREPANCIES OR PROBLEMS

Guests are requested to notify the ITT Office of any discrepancies or problems. These items will be logged for action by the appropriate staff. Guests will be responsible for any damage or missing items noted during their occupancy.

INTERNET USAGE

Due to our remote location we cannot guarantee adequate WiFi service. If our guests require internet during their stay we encourage them to bring their own personal device that they can depend on.

POWER OUTAGES

Compensation is NOT approved in the event of a power outage, unless your cottage is uninhabitable.

LENGTH OF VISIT

Minimum: 2 nights
Maximum: 14 nights

EVICCTIONS

Failure to abide by occupancy standards may result in eviction by MWR Management or a designated representative. A refund will not be provided if this occurs. Future booking privileges will be revoked.

PETS

Pets are prohibited inside, outside and within the vicinity of the beach cottages. A \$200 fine will be assessed for unauthorized pets. Service pets require proper ID.

SERVICE DOG

Upon check in Sponsor / Owner must show valid service dog registration.

MISCELLANEOUS

Customers will be charged a \$50 service fee for after hour assistance to unlock their cottage. The cottages may not be used as a party facility.
