

WHO WE SERVE

- Active duty and retired Navy and Marine Corps personnel and their eligible family members
 - Eligible family members of Navy and Marine Corps personnel who died on active duty or in a retired status
 - Reservists on extended active duty for 30 days or more
 - Indigent widows and dependent parents (65 years or older) of deceased service members who have limited resources and no family to provide for their welfare
 - Ex-spouses who have not remarried and whose marriage to a service member lasted for at least 20 years while the service member was on active duty
 - Discharged veterans who served in Iraq or Afghanistan since 2001 are eligible for CCA Visiting Nurse Program
- In an emergency, the Society can provide assistance for:**
- Food, rent and utilities
 - Transportation expenses
 - Essential vehicle repairs
 - Medical and dental co-pays
 - Disaster relief assistance
 - Funeral expenses

- Interest-free loans and grants for emergency and unexpected financial needs
- Budget counseling and financial education to help you create and manage a monthly budget and save for future expenses
- Free in-home visits by a registered nurse to provide health education, baby wellness check-ups and address other health issues*
- Free in-home visits by a registered nurse to veterans and their family members who have been affected by combat service
- Financial assistance for family members seeking post-secondary education
- Budget for Baby workshops to help expectant parents prepare for the arrival of a new family member. Attendees receive a free Junior Sea Bag with baby items and a homemade blanket
- Thrift Shops offering gently-used uniform items, clothing and household items at very low prices*
- No-Interest Quick Assist Loans (up to \$500) are available to active duty Sailors and Marines to meet financial needs
- Financial assistance for food, shelter and transportation to aid evacuation or recovery from a natural disaster
